The designation will remain in effect until it is modified by the written direction of the student's parent / guardian or the eligible student.</p> <p>You are also hereby notified that school districts are now required to make student records available to "law enforcement officers who are individually designated by the school board and assigned to the school district" in addition to district employees who have been required by the DPI to hold a license and to other school district officials who have been determined by the school board to have legitimate educational interests in the records.</p> <p>Also, the district forwards records to other schools that have requested the records and in which the student seeks or intends to enroll or is already enrolled, as long as the disclosure is for purposes related to the student's enrollment or transfer.</p> <p><b><i>If an injury occurs and requires immediate medical treatment, the nearest medical facility will be requested to treat the child. This form signed by the parent or legal guardian will accompany the child and act as an authorization for emergency care.
